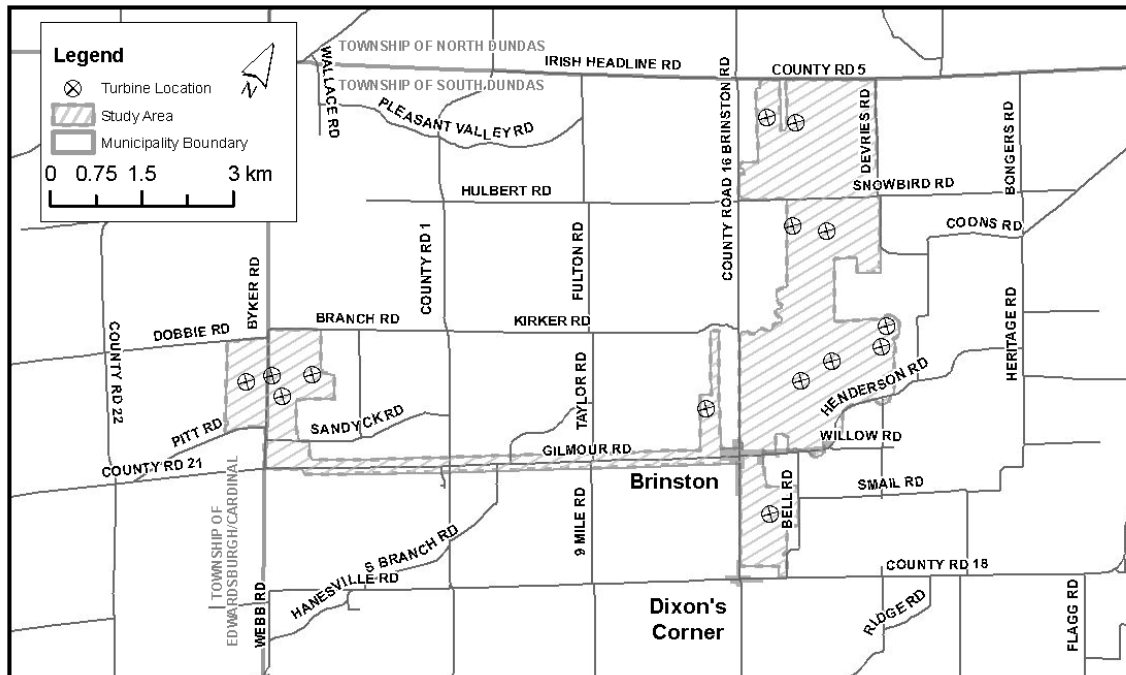

South Dundas Windfarm Limited Partnership through its affiliate EDP Renewables Canada Ltd. has engaged in a renewable energy project in respect of which the issuance of a Renewable Energy Approval is required. The proposal to engage in the project and the project itself are subject to the provisions of the *Environmental Protection Act of Ontario* (Act) Part V.0.1 and Ontario Regulation 359/09 (Regulation). The distribution of this notice of Environmental Registry posting is in accordance with section 15.1 of the Regulation.

**Project Description:** The South Branch Wind Farm is a proposed Class 4 wind facility with a nameplate capacity of the proposed project is 30 MW (megawatts). The project is located near the town of Brinston, Ontario. The project spans two townships; South Dundas Township in the United Counties of Stormont, Dundas, and Glengarry and Edwardsburgh/Cardinal Township in the United Counties of Leeds and Grenville.
