Wheat Field Wind Farm is located in Gilliam County near the city of Arlington in Oregon. The wind farm spans approximately 8,500 acres of private ranchland that overlooks the windswept banks of the Columbia River Gorge.









Wheat Field Wind Farm's generation is equivalent to the consumption of more than **26,000 Oregon homes**.¹

Wheat Field saves more than **172 million gallons** of water each year and prevents the air pollution that causes smog, acid rain, and climate change.²
